What Can HHP Do?



We are here to help. The earlier you let your Area Housing Officer know there is a problem, the better it is for you and us. HHP can work out a repayment plan, provide benefit advice and can help you access advice services. HHP will only agree a repayment plan which is affordable to you.

Legal Requirements



As a landlord, HHP is required to comply with the Housing (Scotland) Act 2001 and 2010. We must satisfy a number of Pre-Action Requirements before we issue a Notice of Possession.

Pre-Action Requirements protect tenants by making sure that landlords take reasonable efforts to provide tenants with advice and assistance before taking legal action.

Legal Action



If you do not pay your rent and do not come to a repayment agreement with us we will take legal action. We will instruct our solicitors to lodge your case in Court. You may be charged additional legal fees if this happens.

Eviction Is The Last Resort



We will only evict tenants as a last resort. We must be able to prove to the Court that it is reasonable for us to evict you (for example you have not contacted your Housing Officer or kept to repayment agreements and arrears continue to rise).

Your Responsibilities



- You must abide by the terms of your tenancy agreement. This means that you must pay your rent regularly and on time.
- If you experience problems in paying your rent you should discuss this with your Housing Officer immediately. You must also respond to any letters or phone calls from HHP, or to any cards that we put through your door.
- Don't ignore this as the problem will not go away. We want to help you address the problem.
- If an arrangement has been made to pay your rent arrears, you must keep to this arrangement. We will do all that we can to support you to meet your responsibilities. If you follow our guidance you can avoid legal action and possible eviction.

Your Responsibilities (cont.)



 If your circumstances change you should contact your Housing Officer immediately. If you are struggling to meet this arrangement please contact us before you break it. We can then discuss a new arrangement.

Paying Rent



Rent money pays for all housing services to tenants such as repairs. It is important that everyone pays their rent or services will be affected.

Your Housing Officer can advise on ways to pay and what to do if you fall behind with payments. Your Housing Officer can also advise you of organisations which might be able to help.
